The Engineering Department consisted of 4 full-time employees for most of 2024 with two vacancies. The City Engineer/Engineering Director position was vacated early in 2024 and it was filled in December 2024. The current Engineer Department is as follows:

Accomplishments in 2024:

- 1) Grants, CIP, Reports, State Aid System, Policies, Studies, Ordinances, etc.
 - Barn Bluff to Covill Trail Awarded \$150,000 in additional Federal monies upon project award
 - Safe Roads for All Federal Safety Study Completed by Toole Design
 - Managing the Municipal State Aid Street System and Financial Needs Annual allotment for 2024 = \$1,212,669 (\$424,434 - maintenance; \$788,235 - construction) from the state gas tax, motor vehicle sales tax & lic. tab fees
 - 5-year street reconstruction plan and CIP updates
 - Right-of-Way permitting and monitoring for private utility installations (Xcel, HBC, etc.).
- 2) Plan review, design and construction on the following projects (City, MnDOT & County)
 - 2023 Neal St Ravine stabilization Punchlist items completed in 2024.
 - 2024 City of Red Wing Bituminous mill, overlay, & ADA improvements Inspected, Constructed & project close out 2/10/25.
 - 2021/2022 Old West Main Street Reconstruction Streetscape features completed in 2023. (Not closed out)
 - Riverfront Trail (Barn Bluff to Colvill) Right of Entry agreement obtained from CP Rail. Final design completed. Project bids received February 2025 with spring 2025 start.
 - Sturgeon Lake Road Overpass Construction started 2024. To be completed in 2025.
 - 2023/2024 TH 61 Bridge over Wither's Harbor Drive Phase 1 (northerly bridge) complete 2023. Phase 2 (southerly bridge) completed 2024.
 - 2024 TH 61 Bridge over CP Rail near MNGL Construction completed 2024.

- 2023-2025 East 7th Street Reconstruction Project Construction started and substantially completed in 2024. Punchlist items to be completed in 2025.
